The amendments are in line with the Constitution 2010, the Kenya Health Policy Direction, the Code of Governance for State Corporations - Mwongozo, the Public Procurement and Disposal Act, 2015 and presidential directives issued from time to time. The amendments also created more departmental functions in the College including that of research and Innovation, and supports the KMTC expansion programme and service delivery.

We have since put in place the required framework to operationalize the research function and allocated a budget to support research activities.

In the 2018-2023 Strategic Plan, the College plans to undertake research in disciplines and matters approved by the Academic Council either directly or through the medium of connected universities, or other colleges, schools, or institutions.

I thank my fellow Board Directors for initiating a process which led to recategorization of the College from PC level 2 to PC level 4A, consequently expanding our mandate to include that of Research, in addition to Training and Consultancy.

Further, the Board has put in place various Policy frameworks to strengthen internal processes and procedures, to ensure compliance with existing Laws and regulations, as well as align with emerging government reforms. These include the Research Policy whose key objective is to encourage creativity and innovation while guiding the application of relevant scientific knowledge and new technologies in areas of health training, research and consultancy.

Thanks to the Policy, our Students are thoroughly imparted with the necessary skills and knowledge to participate in research activities that play a role in the detection, identification, and conduct of research on ecological and environmental factors influencing disease emergence and transmission.

The Students are therefore equipped to become an asset and provide solutions for this country and beyond for generations to come.

The Government through the able leadership of His Excellency President Uhuru Kenyatta has made Universal Health Coverage one of the key agendas.

This agenda requires the concerted efforts of every player in the healthcare sector, and the KMTC Board has been at the forefront to actualize it.
