- ii. Regarding mechanical works;
 - a) the submission of Registration Certificate for Energy and Petroleum Regulatory Authority (EPRA) is not applicable for both the main contractor and the sub-contractor in case of sub-contracting.
 - b) the Registration Certificate for NCA with a valid annual practicing license should be NCA 8 and above for both the main contractor and the sub-contractor in case of sub-contracting but not NCA 6 and above as stated in the tender document.
